**FLCC promotes responsible borrowing. Never borrow more than you need!**

Freshman students may apply for a maximum of \$3,500 annually. Sophomores may apply for a maximum of \$4500 annually after they have completed 32 credit hours or had an equivalent number of transfer credits.

Stafford loans may be subsidized or unsubsidized depending on financial eligibility. Students are responsible for the interest on an unsubsidized loan, which may be paid while the student is in school or accrued and then added to the principle balance when the student enters repayment. Interest on subsidized loans is paid by the federal government while the student is in school.

Independent students may apply for an additional \$6000 annually. Dependant students may apply for an additional \$2000. These additional funds are always unsubsidized.

I permit Finger Lakes Community College to use any Title IV federal aid that I receive to pay for any institutional charges and fees related to my attendance at FLCC from 2009-2010. If I choose to charge books and supplies, a meal plan at the Bookstore, or rent at the College Suites, those charges may be paid from my excess funds after tuition and fees are paid. I may revoke this authorization anytime by writing to the Financial Aid Office.
